

Gifts in Wills

A charitable bequest is a gift specified in your Will. It can be a certain sum of money, a particular asset, or a portion of your estate. A bequest made to Variety - the Children's Charity generates a federal tax credit that offsets the tax otherwise payable on up to 100% of your net income in the year of death. Any unused credits can be carried back one year. These credits may result in significant income tax savings and a corresponding increase in your net estate.

Types of Bequests

<p>Residual Bequest:</p> <p>A donation of all or a portion of your estate to the charity after your debts, taxes, expenses, and other bequests have been paid.</p>	<p>Sample wording for a will</p> <p><i>"I give the residue of my estate (or percentage of the residue of my estate) to Variety - the Children's Charity of BC to be used to help children who have special needs."</i></p>
<p>Specific Bequest:</p> <p>A donation of a piece of property or specific dollar amount, such as real estate, stocks or bonds.</p>	<p><i>"I give the sum of (bequest amount or description of other property) to Variety - the Children's Charity of BC to be used to help children who have special needs."</i></p>
<p>Contingent Bequest:</p> <p>The gift is donated and takes effect only if the primary intention is unable to be met (e.g. if the primary and alternate beneficiaries do not survive the donor).</p>	<p><i>"If neither (name of primary beneficiary) nor (name of alternate beneficiary) survives me for 30 days, then I give (describe amount of cash, property, percentage of residue or other gift) to Variety - the Children's Charity of BC to be used to help children who have special needs."</i></p>
